2. Telephone bids will be accepted via FIVEaa from 6:00am to 6:00pm CST on Friday, 28 November 2025. Telephone bids will be entered electronically into the auction system on the bidder's behalf. No responsibility is taken for any delays in the placement of bids during this process. Telephone bids will close 15 minutes prior to the close of the individual item's auction.
3. Items will be sold to the highest eligible bidder recorded at the close of bidding. Each item's closing time will be promoted online and on air. Winners will be notified on screen and via email. Your first name may be announced on FIVEaa if you are the winning bidder.
